NGA volunteer task group members develop Design Guides, which follow the consensus process with balloting procedures matching existing GTPs.

GSA Facilities Standard References NGA Design Guide

The U.S. General Services
Administration (GSA) Facilities
Standards for the Public Buildings
Service (P-100) was updated this
year. NGA's new Best Practices for
Bird-Friendly Design Guide was
noted as a point of reference for all
US GSA projects considering birdfriendly design.

Influencing Legislation: Advocacy One-Pagers

NGA provides one-pagers on important glass industry issues—like bird-friendly glazing and flat glass global warming potential—in a quick-reference format for the benefit of easy understanding for stakeholders and legislators.

NGA Task Group Develops ASTM Active Shooter Standard


NGA's task group on School and Facility Security developed a new industry consensus repeatable mechanical test method for forced entry of buildings, weakening the glass by shooting in a prescribed pattern, then simulating an attack with a mechanical impactor. This new test method is currently at ballot at ASTM. The task group will develop educational documents and training platforms such as brochures and presentations on how and when to utilize security glazing balanced with risk, threat and vulnerability while examining the incorporation of the glazing into new or existing systems.

Model Building Codes and Glazing Industry Standards

NGA is actively involved with standards and codes bodies including the International Codes Council, ASTM International and ASHRAE, among others, to promote and defend the use of glass in the built environment. NGA's Urmilla Sowell, Tom Culp, Thom Zaremba and Nick Resetar hold leadership positions and represent the glass and glazing industry in the International Code Council (ICC), ASHRAE 90.1, ISO International Standards Organization PAWS: Partnership for Advanced Window Solutions, ASTM and ASC Z97.





Milestones

January 2021: The International Code Council (ICC) Group A proposal submittal process began in January. NGA Code Consultants Thom Zaremba. Tom Culp and Nick Resetar reviewed and made recommendations on all the glass and glazing proposals representing the Glazing Industry Code Committee (GICC) and NGA. GICC submitted a proposal for natural daylighting in schools. Despite strong evidence that daylighting and views enhance the learning environment, the proposal did not pass, facing opposition from the lighting industry. NGA Code Consultants are now focusing on the ICC Group B cycle, which has already begun.

January/February 2021: AT Technical and Advocacy staff held ASTM Glass

Strength meetings. Topics discussed were updates to ASTM E1300 – Standard Practice for Determining Load Resistance of Glass in Buildings which is going through its five-year review before publication.

March 2021: NGA's Advocacy Team supported revisions to the International Code Council (ICC) development processes for the International Energy Conservation Code (IECC). The ICC Board approved switching the development of the IECC from the normal code hearing process to a consensus standards process, using a balanced consensus committee and public review process similar to what is used by ASHRAE, ASTM, ANSI, ISO, and other organizations.

April 2021: ASHRAE 90.1 SSPC 90.1 Energy Standard

for Buildings Except Low-Rise Residential Buildings held their Spring Interim meetings where the NGA Advocacy Technical team represented the glass and glazing industry. The meetings included discussion of a simplified method for the design of buildings and building envelope materials.

April 2021: ISO International Standards Organization Technical Committee 160: Glass in Buildings held a meeting of the Chairman Advisory Group (CAG) in April. The CAG discussed updates to ISO TC 160 standards for Glass in Buildings including BIPV, dynamic glazing and glass strength.

April 2021: Urmilla Sowell, NGA Technical and Advocacy Director, participated in ASTM Committee E06 on Performance of Buildings and Committee F12 on Security Systems and Equipment. Work group topics included Design of Glass Railings, Guards and Balustrades, Sealed Insulated Glass, Security Glazing, Glass Floors & Stairs, and Impact Resistance. Several security standards and glass strength standards were balloted this summer.

June 2021: The ASC 797 Committee, administered by NGA, is the group of member companies maintaining and leading the development of the ANSI Z97.1 voluntary standard for safety glazing materials used in buildings. The Committee re-approved the ANSI Z97.1-2015 (R2020) version of the standard and will be preparing to initiate its fivevear review process soon in anticipation of publishing

the 2025 version.

August 2021: The California **Energy Commission** approved a resolution adopting the 2022 Energy Code, commonly known as Title 24. The 2022 Energy Code will go into effect on January 1, 2023, following expected approval by the California Building Standards Commission. NGA's advocacy team provided feedback on proposed changes to the teams developing the Title 24 update over the last two years. Overall. the new version of Title 24 will make significant advancement towards the state's energy efficiency and climate change goals while also meeting their cost effectiveness requirements.

September 2021: The PAWS: Partnership for Advanced Window Solutions is a new initiative

bringing together the DOE. NEEA. LBNL. manufacturers, utilities and efficiency advocates to increase demand for highperformance windows. Initially the program targets residential R5 windows but plans to expand to promote advanced commercial framing and glazing. The program was introduced at NGA Glass Conference: September by Stephen Selkowitz of LBNL, NGA Code Consultant Tom Culp and several NGA member companies are involved.

October 2021: ASTM Committee C14 updated and published several new standards for the glass industry, including a new test method for anisotropy (visual distortion) in glass.


